Matters arising: Follow up received from Councillor Watson

- **Peel Road Gulleys** Road's response:

All gullies on Peel Road were assessed as part of the cyclic gully route last year and most gullies are now clear and running. We are aware of a couple of gullies which require further investigation via excavation however, as they are not causing any significant flooding issues we intend to undertake these works in the new financial year.

If you have specific locations of the blocked gullies referred to, I would be happy to investigate this further.

- **Peel Road Verge Damage**

Abbey Construction Beechwood Lea

Planning response: I can confirm that both Westpoint and Abbey Construction are working on different parts of the site. We have made contact with them to ensure that all the damage to the road and verge are repaired.

No repairs have been made and this will be followed up prior to the March CC meeting.

- **Beechwood Lea road adoption:**

Road's response: Please be advised that Westpoint Homes have been constructing the road in accordance with their approval gained under the Roads (Scotland) Act 1984. The construction of the new road has been inspected at various stages and whilst the works have been largely completed, there remains outstanding works to the bridge.

Various concerns have been raised with the developer and we await the completion of the necessary works to the bridge before the Council is able to move forward the adoption process.

Following the satisfactory completion of these works the road will be placed on a one year's maintenance period and after this, should no defects be observed, the road and bridge will be formally adopted.

Chair's Report:

1. Latest on Planning Application for neighbourhood centre at Peel Road, Thorntonhall: In February when there were 869 total comments, the numbers broke down as follows: 329 comments were from Thorntonhall and of these, 87.5% were objections. The large numbers supporting the application were mainly from people living outside the area, many did not include full address and comments were quite often inaccurate and sometimes inapplicable. This has been brought to the attention of the planning department.

2. The Open University of Scotland has recently added to their 'Openlearn' online courses to include training materials designed for Community Councillors. These are free and can be accessed any time. The courses include digital skills, finance, fundraising, community, and business skills. The OU can also advertise job opportunities with the Community Council, which could include temporary and voluntary things like website design and minute taking. This could be a way of engaging an OU student looking for practical experience and/or some kind of project. The OUs next relevant Webinar will be on the subject of getting younger people involved in Community Councils. 3. A litter pick was carried out on 28th January on Peel Road Thorntonhall between Frederick Boulevard and the gate recently used for fly tipping. It was called at short notice. Suggest the next one be at Jackton, on Sunday 17th March 11am-12.15 for the greenspace to the east side of the new spine road, Newhouse Road...Meeting at the access road to the Jackton Primary School. I will put it on the group page for JTCC, Jackton Friends and EK Litter Pickers. On a side issue, the Newhouse Road needs dog waste bins, and SLC been notified.

4. Regarding road flooding on Eaglesham Road, Jackton (when there is heavy rain) from overtopping main sewer manhole covers, Scottish Water are to conduct a CCTV check and get back to us.

Updates

- **Network Rail Enhancements**

J Edwards reported on the public Network Rail meeting held on February 20th in East Kilbride.

- A temporary footbridge will be built on the right side of the bridge of the Thorntonhall station and will be accessed via the old Waterfoot footpath, crossing onto the vacant ground opposite.
- Works on the bridge will begin in May but utility services running across the bridge will need to be relocated before it can be demolished. This will take place in September.
- Rail services will be stopped for 2 days for demolition otherwise normal train service is planned.
- Some platform alterations will be required at Thorntonhall to adjust the gap between the train and platform. A date for this was not given.
- Network rail reported that the new Hairmyers Station and parking facility are fully funded and unaffected by the recent budget cuts by the Scottish Government.
The shortfall affects the SPT park and ride portion of the facility and alternate sources of funding are being investigated.

D. Eunson asked if traffic calming measures could be incorporated into the new Peel Road rail bridge design.

F. Corbett raised the poor road condition of Peel Road heading south from the rail bridge to the junction with Thornton Road and if resurfacing works were planned before or during the road closure.

Councillor Watson and Williams will be consulted on both questions.

- **Change in free transport for high schoolers from 2 miles to 3 miles.**

The consultation period is closed. The CC will comment if decisions result in safety issues for students in our area.

- **Road Closures & Works**

Emergency road closure: Holehouse Highway is closed between Hole of Dripps Farm and Holehouse Sewage Works from Wednesday 31 January to Sunday 10 March due to structural damage to the ford. Diversion via Peel Road, B764 Eaglesham Road, B764 Cheapside Street, Gilmour Street, Holehouse Road.

Thornton Road is closed between Peel Road and Thornton Farm from Monday 11 December to Tuesday 9 April 2024 to replace the railway bridge. Diversion via Peel Road and Braehead Road.

Braehead Road is closed between Braehead House and Thornton Road from 10am to 12pm on Wednesday 17 April for Scottish Water maintenance works. Diversion via Peel Road, Eaglesham Rd, Redwood Dr, Barbarra Rd and vice versa.

Other Business

- **Sheep Worrying**

A local farm has reported dog worrying of pregnant sheep. Sheep are valuable assets and any harm to them harms a farmer's livelihood.

Chasing by dogs can do serious damage to sheep, even if the dog doesn't catch them. The stress of worrying by dogs can cause sheep to die and pregnant ewes to miscarry their lambs, or serious injury by their panicked attempts to escape, causing untold damage to fence and field boundaries in the process.

It is vital that you keep your dog on the lead around livestock, even if you can usually trust it to come to call. If you live in or near a farming area, you must make sure that your dog cannot escape from your property, as it may find its way onto land containing sheep.
