Minutes of the meeting May 15th, 2024

Matters arising:

P. Harvey stated that the minutes included only a summary of the BESS portion of the meeting instead of the full recorded transcript. Additionally, concerns that some issues raised during the meeting were missing and, it did not reflect the majority's objections to the proposal. The Secretary explained that, unfortunately for technical reasons, the transcript of the BESS presentation and subsequent questions and answers was very unclear and therefore mostly unintelligible. The Vice Chair agreed to investigate this further and try to translate the transcript into something which made sense. He also said that subsequent email communications issued by the community council since the meeting on 15 May which would be mentioned in the Chairs report (see below) reflected that of all the residents who spoke at that meeting were against the proposed development for the reasons mentioned in the emails.

(NOTE: Subsequent enquiries with the Scottish Information Commissioner resulted in advice that, for legal reasons, the community council would have been unable to publish the transcript of the BESS presentation and subsequent questions and answers.)

Approval of the minutes was postponed until the majority of Community Council members could discuss the matter.

Chair's Report: Claire Marr

BESS

1. Following the May meeting, I sent an email to South Lanarkshire Council and local councillors about the screening request (EK/24/0179), raising issues expressed at the meeting (see point 3 for detail). This was copied to the Beachwood Lea flats.
2. Also, a similar email to the Scottish Government ECU and MSP.

3. The email specifically referred to concerns about:

(i) noise nuisance to the nearest residential properties and absence of regulations on this,

(ii) Fire risk, fumes and thermal runaway and absence of regulations on this.

(iii) Visual intrusion.

(iv) Greenbelt and damage to the core footpath

(v) Local roads being unsuitable for construction traffic.

(vi) Need for an environmental impact assessment (although SLC have taken the view that it does not require an EIA)

(vii) alternative sites like business/industrial locations or brownfield locations would be more appropriate.

4. Next, we will need to wait until a planning application is submitted, which could take several months.

5. Although we asked for a Q and A webchat from Apatura, this has not materialised.

6. If anyone is interested in seeing (and hearing) an operational BESS, then the nearest one is located at Ardochrig on the east side of the Whitelee Windfarm and approximately 3 miles south of East Kilbride. It is a 50-megawatt facility so has approximately a third of the battery containers proposed at Thorntonhall. The Ardochrig BESS is run by Scottish Power. There appears to be no Apatura BESS currently operational. (Their online information suggests that they will start to be operational in 2026.)

Directions to the Ardochrig BESS: Take the Strathaven Road out of East Kilbride. Turn right at Rutherend Toll Cottage. Continue through Leaburn and take the next left turn. Travel uphill for approximately one mile until you see double yellow lines and a small car park on the right. Park and walk 200-250 meters into the woodland to find the BESS.

CALA PLEDGE initiative, Jackton.

I requested input from the public via Facebook regarding their preferences for community improvements, which I subsequently relayed to the Cala representative.

The majority of the suggestions pertained to play areas, particularly those suitable for older children. I will provide an update on the Friends of Jackton Facebook page regarding the next steps

A BIG THANK YOU to the two volunteers (Trish Harvey and her son Geoff) who cleared the fly tipping at the gate on the north end of Peel Road.

It was suggested by a member of the public that a form of road block or boulders be used to block access from the road to prevent further fly tipping in this area. As the land is private, this would require permission of the owner.

Kingsland View, Jackton closed between Ocean Drive and its termination from 9.30am to 9pm on Friday 2 August for Scottish Water manhole repair.

Holehouse Highway is closed between Hole of Dripps Farm and Holehouse Sewage Works from Wednesday 31 January to Monday 10 March 2025 due to structural damage to the ford. Diversion via Peel Road, B764 Eaglesham Road, B764 Cheapside Street, Gilmour Street, Holehouse Road and vice versa.

Updates

Hairmyers Station Funding

Park and Ride full funding has been secured for the completion of the new Hairmyers Station parking area.

Thorntonhall Station Bridge. There has been no further information from Network Rail on the bridge design. The planned road closure has been removed from the SLC web page.

Jackton Primary School Out of school hours care provision. The Head teacher is hoping to finalise breakfast club arrangements in the next week. Discussions are underway for after school arrangements for the next school term.

Other Business

Overgrown Verges and bushes along Braehead Road.

The hedges are not scheduled to be trimmed until October due to nesting.

As a guide, rural road verges are cut once a year with additional cuts programmed at certain road junctions for safety reasons from April through to October.

**A request has been made by the CC to SLC to ask if the verges can be cut as they are encroaching on the road making sightlines and passing difficult.*

Road Signage

SLC have been notified to pick up the redundant Closed Road signs on Braehead Rd.

Bookings required for the Recycling Centre from August 24th.

From August 24, 2024, a booking will be required to drop off items at the East Kilbride Recycling Centre. Information on how bookings can be made will be sent out when available.

Caravan, Waterfoot Road

A question was raised if the residential style caravan sited on Waterfoot Road about half a mile from the junction with Peel Road is permitted under the planning regulations and if the plumbing system meets required regulations.

Speed reduction measures and crossing points. Eaglesham Road, Jackton

Speed reduction measures and crossing points are needed on Eaglesham Road, Jackton.

Can the 30MPH speed limit be extended to the junction with Hayhill Road?

One crossing point has been installed but not completed. When will this be put in service?

Poor pavement condition. Eaglesham Road Jackton

Stretches of the pavement between the new Jackton roundabout and the police college are uneven, narrow and in poor condition making it difficult to navigate, especially with a buggy or younger children on bicycle. Are there plans to improve this?

Can cycle lanes be incorporated into new roads in the area?
